### Geocaching Guidelines

A policy to define, authorize and regulate Geocaching along the Paint Creek Trail.

- 1). All geocaches must adhere to [www.geocaching.com](http://www.geocaching.com) and [www.mi-geocaching.org](http://www.mi-geocaching.org) standard guidelines for placement.
- 2). Per the Uniform Trailways Regulations, participants will adhere to the following ordinances when placing or seeking a cache:
  - a) **Motor Vehicles**  
No person shall drive, propel or park a motor vehicle or motorized sports equipment of any nature upon Trailways property.
  - b) **Natural Features**  
No person shall dig for, remove, injure or destroy any tree, flower, shrub, plant or growing thing or any wild bird or animal, or any earth, rock or other material within the boundaries of the Trailways land without written permission from the Trailways Commission.
  - c) **Damage to Property**  
No person shall injure, deface, disturb, befoul, change or remove any portion of any marker, structure, equipment, fence or any other property within Trailways land.
  - d) **Trespass to Adjacent Lands**  
No person shall go onto land adjacent to Trailways land which is in private ownership, without the expressed permission of the owner of the land. The person going onto any such land shall be the owner or a member of the family of the owner, or carry in his or her possession written permission allowing entry onto the private land, signed by the owner.

- 3) The Paint Creek Trailways Commission reserves the right to remove any cache without notification.
- 4) Caches must be placed within 20 feet on either side of the Paint Creek Trail surface.
- 5) Participants must respect the existing trail and not create any new ones.
- 6) To place a cache along the Paint Creek Trail a person must obtain a permit. Permits can be obtained, at no cost, from the Trailways Commission office via the internet, mail, fax, email, or in person.
